Note: - The contractor will have to be deposited amounting to **Rs. 10,00,000/-** as security within a week from the date of issue of work order & before start of lifting. The security will be forfeited if the work is found unsatisfactory or the contractor fails to execute the work during the period of agreement.

Terms & Conditions:-

1. Any person, party, firm, company is not eligible to participate if he, any party, any director has any liability toward mill of past years. Every party needs to give list of partner of firms, director of companies in tender, else will be ineligible.
2. Transportation Charges: In purchaser scope.
3. The purchaser has to deposit the advance amount of the estimated production every ten days. In case of no deposit, the contract will be cancelled.
4. SGST/CGST/UGST/IGST will be extra as applicable as per norms (Our GST No. 06AAACN0454G1ZV).
5. TDS will be deducted as per GST Rules (if applicable).
6. The rate will remain same throughout the season and shall not be revised in any condition.
7. The press mud sold by us has to be used for agriculture purpose only.
8. The purchaser has to make his own arrangement for removal of press mud from the chute to the dumping yard outside the factory premises, and should be far away from highways & residences. The purchaser has to make proper arrangement of the transporter in such a way so that the discharge chute at our factory does not scatter on the ground. The entire discharged mud must be loaded directly in the vehicle.
9. You will be fully responsible for any accident occurring during the ordered job.
10. You should strictly adhere to the rules and regulations regarding disposal of press mud as per guidelines provided by HSPCB.
11. That the contractor shall be responsible for satisfactory performance of working during the entire contract period under supervision of officer authorized by the management.
12. That in case of any dispute, the opinion of the management will be final and binding for the contractor.
13. That the free accommodation, lighting, and water facility will be provided for stay of contractor and labor engaged by the mills during the contract period.
14. The contractor will comply with the provision of factory Act, Provident fund Act, W.C. Act, Income Tax etc. All the Taxes and levies as applicable shall be paid by the contractor as per rules.
15. The Contractor shall be responsible for any accident that occurs during the allotted job.
16. If the work of contractor is not satisfactory, the contract is liable to be terminated immediately without any prior notice.
17. The contractor will ensure compliance of labor laws. There will be no relationship of master and servant between the company and persons engaged by the contractor.
18. The contractor shall get registration under the contract labour (Regulation & Abolition) Act, 1970.

19. All statutory liabilities or your employees will be paid by you such as workman compensation, P. F. etc. and you will cover your personnel for accident and death whilst performing the duty. Our concern will not be liable in any way.
20. The contractor will ensure that all your employees maintain peace and discipline in the factory premises and the company will have the right to check and search you and your employees at any time.
21. The contractor will ensure that person engaged by you should not be minor or female.
22. The company has right to terminate this contract at any time without any notice or assigning any reason.
23. If at all H-1 party regret to work the ordered job, then Mills Board shall have the right to award the order to second highest party on the finalized rates in the interest of the Mills.
24. Board/Management of the Mills shall have the right to black-list the defaulter party from the Mills.
25. Board/Management of the Mills shall have the right to negotiate with other participant also if quoted rates of H-1, H-2 & H-3 party are not seems upto the marks in the interest of the Mills.
26. If any difference of opinion arises during the course of work, the decision of the mill management shall prevail.
27. Any damage caused to the mill due to interruption in work will be compensated by the party.
28. Rates are to be quoted on the basis of above said terms & conditions.
29. Conditional tender will not be accepted.
30. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason.
31. Disputes of any nature that may arise in connection with the execution of this sale order shall be governed by the laws of India and subject to the jurisdiction of Court situated in Naraingarh (Haryana) only.
