The security will be forfeited if the work is found unsatisfactory or the contractor fails to execute the work during the period of agreement. Terms & Conditions for contractual jobs:-

- **1.** Following technical & skilled persons are to be provided by contractor, round the clock, during the operation of the contract.
 - a. Supervisor in general shift 01 No.
 - b. Operators in each shift 01 No.
 - c. Helpers in each shift 01 No.
- 2. ETP & STP operation and maintenance work to be done by the contractor.
- 3. Adherence to parameters & data transfer on OCEMS shall be the responsibility of the contractor.
- All consumable items like Cow dung, Lime, Chemicals, DAP, Urea, Lubricants, Electric power etc. will be provided by the Mills free of cost. Running repair and maintenance shall be carried out by contractor.
- 5. All civil structures will be handed over to contractor neat & clean upto your satisfaction which should be handed over to the mill in the same condition after completion of the contract.
- 6. All parameters of the treated effluent from the discharge point of ETP and storage lagoon should be within the norms prescribed by HSPCB & CPCB.
- Every month the samples of treated & untreated water are to be got tested from the HSPCB approved NABL certified lab and report will be submitted by contractor to the mill at your own cost.
- Oil & grease catcher and sludge beds will be regularly cleaned by contractor and recorded in the log book.

- 9. Contractor will maintain & update the ETP log book on daily basis which should be made available to the visiting officers of the mill & other Govt. Officers.
- 10. Contractor will be responsible for cleaning of the entire inlet & outlet drain pipes of ETP & STP including surrounding area.
- 11. The Mill has the right to check the work & presence of staff posted by you at E.T.P. & S.T.P. at any time.
- Free boarding & lodging will be provided by the Mills to supervisor (general shift) in guest house
 & to sr. person (s) during plant visit. Only living arrangement to your operators & helpers at
 E.T.P. site will be allowed.
- 13. Contractor will start the work one month before from start of the crushing season.
- 14. In case of any accident of your worker during the execution of the above contract, you will be fully responsible to pay the compensation as per act prevailing & will follow all safety measures as per Rules.
- 15. Contractor will submit the list of workers / staff engaged by you for the jobs allotted at security gate of the Mills, The list must contain name, father's name, permanent address and age of workers, with copy of Aadhaar Card. You will not engage any worker under 18 years of age.
- 16. You will not transfer part or full contract to any other firm.
- 17. If contractor is unable to operate the ETP & STP as per guide lines issued by HSPCB / CPCB, then the Mills has right to cancel your contract without any notice and the contract will be awarded to any other party at your risk & cost.
- 18. The contractor will take up the jobs immediately and ensure the satisfactory completion as per the instructions of Mill's Engg. Head. If your progress remains poor, then this work will be got done at your risk & cost and no correspondence will be entertained.
- 19. Any damage caused to the mill due to interruption in work will be compensated by the contractor.
- 20. The contractor will ensure that all his employees maintain peace and discipline in the factory premises and the company will have the right to check and search you and your employees at any time.
- 21. The contractor will ensure that any person engaged by him should not be minor or female.
- 22. If any difference of opinion arises during the course of work, the decision of the mill management shall prevail.
- 23. The contractor will follow all laws of land.
- 24. The bills will be get checked from an independent bill checker for the quality of work done.

- 25. The contractor will ensure compliance of labor laws. There will be no relationship of master and servant between the company and persons engaged by the contractor.
- 26. The contractor will provide safety items to his labour & for any accident if occurs during the allotted job the Contractor shall be responsible for that.
- 27. The Mill will not be responsible to pay any compensation for any accident or mishap, which may occur during the execution of the contractual jobs.
- 28. Required insurance covers for your workman and machinery shall be arranged by you as per Law on your own risk and responsibility.
- 29. The contractor shall get registration under the contract labour (Regulation & Abolition) Act, 1970.
- 30. All statutory liabilities or your employees will be paid by contractor such as workman compensation, P. F. etc. and you will cover your personnel for accident and death whilst performing the duty. Our concern will not be liable in any way.
- 31. The contractor should be registered with P.F. Department or have applied for registration.
- 32. You will be fully responsible to comply with Factory Act, 1948, the Employees Provident Funds & Misc. The Employees State Insurance Act, 1948, the Payment of Wages Act, 1936, the Minimum Wages Act, 1948, the Industrial Disputes Act, 1947 and the workmen's compensation Act, 1923 and industrial contract act.
